PREPARATION FOR MARKING

SCORIS

TRADITIONAL

MARKING

- Mark strictly to the mark scheme.
- 2. Marks awarded must relate directly to the marking criteria.
- 3. The schedule of dates is very important. It is essential that you meet the scoris 50% and 100% (traditional 50% Batch 1 and 100% Batch 2) deadlines. If you experience problems, you must contact your Team Leader (Supervisor) without delay.
- 4. If you are in any doubt about applying the mark scheme, consult your Team Leader by telephone, email or via the scoris messaging system.

- 5. Work crossed out:
 - a. where a candidate crosses out an answer and provides an alternative response, the crossed out response is not marked and gains no marks
 - b. if a candidate crosses out an answer to a whole question and makes no second attempt, and if the inclusion of the answer does not cause a rubric infringement, the assessor should attempt to mark the crossed out answer and award marks appropriately.
- 6. Always check the pages (and additional objects if present) at the end of the response in case any answers have been continued there. If the candidate has continued an answer there then add a tick to confirm that the work has been seen.
- 7. There is a NR (No Response) option. Award NR (No Response)
 - if there is nothing written at all in the answer space
 - OR if there is a comment which does not in any way relate to the question (e.g. 'can't do', 'don't know')
 - OR if there is a mark (e.g. a dash, a question mark) which isn't an attempt at the question.

Note: Award 0 marks – for an attempt that earns no credit (including copying out the question).

USING THE MARK SCHEME

Please study this Mark Scheme carefully. The Mark Scheme is an integral part of the process that begins with the setting of the question paper and ends with the awarding of grades. Question papers and Mark Schemes are developed in association with each other so that issues of differentiation and positive achievement can be addressed from the very start.

This Mark Scheme is a working document; it is not exhaustive; it does not provide 'correct' answers. The Mark Scheme can only provide 'best guesses' about how the question will work out, and it is subject to revision after we have looked at a wide range of scripts.

The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co–ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co–ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- The specific task-related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	Generic mark scheme for Section A, Questions 1 and 2: Essay [30]
Level 5 25–30 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed. There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 19–24 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made. There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3 13–18 marks	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and analysed in parts of the answer, but in places knowledge is imparted rather than being used. The analysis is appropriately linked to the judgements made, though the way in which it supports the judgements may not always be made explicit. The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
Level 2 7–12 marks	The focus is more on the topic than the specific demands of the question. Knowledge and understanding is limited and not well used, with only limited evaluation and analysis, which is only sometimes linked appropriately to the judgements made. The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.
Level 1 1-6 marks	The answer relates to the topic but not the specific question. The answer contains only very limited relevant knowledge which is evaluated and analysed in a very limited way. Judgements are unsupported and are not linked to analysis. Relevant knowledge is limited, generalised and poorly used; attempts at argument are no more than assertion. Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.

The evaluation may be un-even with only limited treatment of either limitations or strengths, but both will be addressed.
Level 2 5–8 marks	The answer has a limited analysis of the interpretation. It uses generalised knowledge of the historical context and shows limited understanding of the wider historical debate, in the form of generalised reference to other interpretations, in order to produce a limited evaluation of the given interpretation. The evaluation may deal with either strengths or limitations in a very superficial way, or may only address limitations or strengths.
Level 1 1–4 marks	The answer has a very limited analysis of the interpretation which may be descriptive and relate more to the topic area than the detail of the interpretation. It uses very limited and generalised knowledge of the historical context and shows very limited or no understanding of the wider historical debate, with reference to other interpretations being implicit or lacking, in order to produce a very simplistic, asserted evaluation of the given interpretation.

1*	 How far was economic crisis the main reason for the 1830 revolution in France? In relation to the given factor, candidates may argue that economic problems from 1826 onwards provided a background of popular discontent and it was the workers, unemployed and students of Paris that threw up the barricades in the 'Three Glorious Days' of July and who, with the disbanded National Guard, fought the army. However, candidates may well argue that it was a combination of other factors that were of greater significance in the overthrow of the monarchy. Candidates might refer to long term (such as the revolutionary heritage), short term (such as Charles X's policies towards religion) and immediate causes (such as the Ordinances of St Cloud). Candidates may also discuss reasons, such as the legacy of the revolutionary and Napoleonic era, the Charter and the attitudes of Charles X, Ultras and liberals towards it, liberal propaganda, the range and nature of Charles X's political and religious policies and his appointments. 	30	 No set answer is expected. At Level 5 there will be judgement as to the relative importance of the reasons. At level 5 answers might establish criteria against which to judge the relative importance of the reasons. To be valid, judgements must be supported by relevant and accurate material. If not, they are assertions. Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.

2*	 'Louis Philippe's foreign policy was not effective.' How far do you agree? In arguing that the policy was not effective, answers might consider the rupture with Britain over Spain in 1846 and the unpopularity that emerged from too much friendship with England earlier. Answers might consider that the policy of Thiers towards Mehmet Ali led to a failure to protect a French protégé. Answers might suggest that bringing back Napoleon's remains pointed out the difference between the Napoleonic successes and the limited impact of Louis Philippe's policy. In arguing that the policy was effective, answers might consider that Louis Philippe was wise to accept an international agreement over Belgium and that the expulsion of the Dutch king was in France's interests. Answers might consider that increasing cooperation with Great Britain established support for a liberal monarchy. Answers might consider cooperation with Britain against Russian expansion in protection of French trading interests in the Levant. 	30	 No set answer is expected. At Level 5 there will be judgement as to the relative effectiveness of his policy. At level 5 answers might establish criteria against which to judge the relative effectiveness. Randell, France: Monarchy, Republic and Empire 1814—70, 1986 Evaluate the strengths and limitations of this interpretation, making reference to other interpretations that you have studied. • The historical debate about the liberal Empire under Louis Napoleon centres around developments in the 1860s and whether a liberal Empire was established, whether it was limited to economic developments or included political and the reasons for the developments. • In analysing and evaluating the strengths and limitations of the interpretation, answers might consider whether the Empire was actually liberalised and, if it was, the reasons for it. • In analysing and evaluating the strengths of the given interpretation, answers might use knowledge and understanding of:	20	 No set answer is expected. Candidates must use their knowledge and understanding of the historical context and the wider historical debate surrounding the issue to analyse and evaluate the given interpretation. Candidates must refer to at least one other interpretation. The quality of analysis and evaluation of the interpretations should be considered when assigning answers to a level, not the quantity of other interpretations included in the answer. Other interpretations considered as part of evaluation and analysis do not need to be attributed to specific named historians, but they must be recognisable historical interpretations, rather than the candidate's own viewpoint. Answers may include more on strengths or more on limitations and there is no requirement for a 50/50 split in the evaluation, however for level 5 there should be well-supported evaluation of both and for level 4 supported evaluation of both, in line with levels descriptors. Candidates are not required to construct their own interpretation.

•	 the growth of opposition within France during the 1850s and the results of elections the fear of urban discontent and mob violence opposition from newspapers Napoleon's desire to cling on to power at all costs. In analysing the limitations of the given interpretation, answers might use knowledge and understanding of: Napoleon's desire to move in a more liberal direction the decree of 1860, the changes of 1869 and the appointment of Ollivier the support for nationalism in Europe. Other interpretations that might be used in evaluation of the given interpretation are: interpretations focusing on a combination of Napoleon's desire and political expediency interpretations that consider that the regime was never liberal and consider the shackling of the press and political parties, the constitution that gave him absolute power for ten years and the centralised and authoritarian nature of the state interpretations that emphasise there was liberalism only in the economic sphere.
